Mayor Jenkins opened the regular meeting of the Gaylord City Council with prayer by Council Member Wambold at 7:00 p.m. on Monday, October 10, 2011, in the City Council Chambers, located in the Gaylord City Hall, 305 East Main Street, Gaylord, Michigan. The Pledge of Allegiance followed the invocation.

Members Present: Duczkowski, Jenkins, Mankowski, Sharrard and Wambold.

Members Absent: Campbell and Johnson.

Motion by Wambold, support by Sharrard, to dispense with the reading of the minutes of the previous meeting and to accept them as presented.

Ayes: Unanimous. Motion carried.

Mayor Jenkins convened the public hearing at 7:02 p.m. to receive public comment regarding the closeout of a Community Development Block Grant funded infrastructure project to make improvements to the Waste Water Treatment Plant and north Water Tower (MSC209163-ICE). City Manager Duff described the scope of the project and the source and amount of funds expended. Mayor Jenkins solicited questions and comments from the Council and public in attendance. No questions or comments were received regarding the project.

Motion by Duczkowski, supported by Sharrard, to amend the agenda for the meeting by adding under New Business, the following: Resolution Authorizing City Manager and City Clerk to Sign Documents Relating to Property Purchase.

Motion by Duczkowski, supported Sharrard, to authorize City Manager Joseph Duff and City Clerk Rebecca Curtis to sign all documents relating to the purchase of the 5.13 acre piece of property, adjacent to Aspen Park.

Motion by Sharrard, supported by Wambold, to excuse the absence of Council Members Campbell and Johnson from the meeting.

Ayes: Unanimous. Motion carried.

Council Members directed a letter supporting the continuation of the Gaylord Postal Processing Center.

Mayor Jenkins closed the public hearing at 7:21 p.m.

Motion by Sharrard, supported Duczkowski, to award the bid for the purchase of a police vehicle to Feeny Chrysler-Dodge at a bid price of \$23,817. The bid of Feeny's was the only bid received.

Request by Dave Matelski, of American Waste to participate in a recycling program was tabled until a future meeting.

City Manager Joseph Duff reported on the September 27, 2011, Street Committee Meeting and reviewed proposed projects for 2012.

Motion by Wambold, supported by Sharrard, to accept the proposal in the amount of \$81,200 from C2AE for engineering services relating to the 2012 Street Improvement Project.

Motion by Wambold, supported by Mankowski, to approve a request for a Charitable Solicitation Permit from the Gaylord Lion's Club for their annual "White Cane Sale" to be held October 14-15, 2011.
